CONDITIONS OF WORK ORDER CONTRACT ACCEPTANCE

*While conducting a detailed inspection of a marine vessel(s) or its machinery, known as a MARINE VESSEL SURVEY, it is necessary for the attending surveyor to open and/or remove any hatch covers and to open any compartments, possibly including electrical enclosures containing energized circuits. Safety guards for rotating machinery and various other safety interlocks and switches may be disabled during the survey. These procedures are inherently dangerous and make movement around or presence aboard the vessel extremely dangerous. I, the undersigned, clearly understand the dangers inherent in being aboard or around the vessel while the vessel is being surveyed, and by my signature below, I certify that I release Robert P. Stefanowicz, D/B/A Susquehanna Marine Surveys (the attending surveyor) from all responsibility and liability for my safety, without limit and without reservation.

*Acceptance and use of the produced final report by the client acknowledges the client's understanding that the report has been composed of information that is believed to be true after reasonable investigation and inquiry but is not warranted to be so. The information was obtained without drilling, diving, ultra-sonics, cleaning or opening up to expose parts or conditions ordinarily concealed. There were no tests for tightness or soundness conducted other than the conditions noted visually.

*Acceptance and use of the produced final report acknowledges the client's understanding that no determination of stability or structural strength has been made and no opinion is expressed.

*Acceptance and use of the produced final report acknowledges the client's understanding that Robert Stefanowicz dba/ Susquehanna Marine Surveys, does not accept any responsibility for damage or deterioration not found or discovered during the course of survey, nor for consequential damage, deterioration, or loss due to any error or omission.

CONDITIONS OF WORK ORDER CONTRACT ACCEPTANCE continued:

*The Client hereby undertakes to keep the Surveyor/Consultant (Robert Stefanowicz dba/ Susquehanna Marine Surveys) and its employees, agents and subcontractors indemnified and to hold them harmless against all actions, proceedings, claims, demands or liabilities whatsoever or howsoever arising which may be brought against them or incurred or suffered by them, and against and in respect of all costs, loss, damages and expenses (including legal costs and expenses on a full indemnity basis) which the Surveyor/Consultant may suffer or incur (either directly or indirectly) in the course of the services under these Conditions.

*Notwithstanding the above clause, in the event that the Client proves that the loss, damage, delay or expense was caused by the negligence, gross negligence or willful default of the Surveyor/Consultant aforesaid, then, save where loss, damage, delay or expense has resulted from the Surveyor's/Consultant's personal act or omission committed with the intent to cause same or recklessly and with knowledge that such loss, damage, delay or expense would probably result, the Surveyor's/Consultant's liability for each incident or series of incidents giving rise to a claim or claims shall never exceed a sum calculated on the basis of ten times the Surveyor's/Consultant's charges.

*This report may not be sold to any other entity or person(s) or given to any other entity or person(s), other than as described in the scope of survey on page 1 of the final report, by the client named on this work order contract. Use of this report constitutes acceptance of these terms and those of the Scope of Survey, its limitations and advisories, and any other specified limiting conditions or restrictions.

*The survey will be made, and the report will be prepared, signed, and submitted in confidence to the person on whose behalf was performed without prejudice to the rights or interests of whom it may concern. Only the original report that is identified by this surveyor's embossed stamp at the bottom of each page along with a gold seal embossed with this surveyor's membership on the last page and this surveyor's signature is embossed with his second membership seal, will be verified. Any fraudulent use of the produced final report will be prosecuted by the fullest extent of the law.

*It is also understood and agreed by me, the undersigned, that the services as agreed and listed above, be conducted by Robert P. Stefanowicz, AMS, as the attending surveyor, will be performed to the best of his abilities. Any reports furnished either oral or in writing will be accepted as his best judgment. These reports are not intended as a guarantee or warranty, either expressed or implied, as to the condition of the vessel(s) / machinery in question or any of its parts or contents. It is further understood and agreed upon that Robert P. Stefanowicz D/B/A Susquehanna Marine Surveys, will be held harmless and not responsible in any way or form for any loss or damage, direct or consequential, arising out of the condition of the vessel(s) or machinery being surveyed, services performed or by reason of any error or omission on his part as the attending surveyor. I, the undersigned, further agree that this release must apply fully to my estate and any of my heirs without limit or reservation.
